

REVENUE



REVENUES

- Real Estate Taxes are showing a 35% increase over last YTD, or a difference of \$1.7 million.
- Rollback and Homestead came in at \$708,274, which is \$20,000 lower than last year.
- Income tax is now down 2.6%.
- ODE Funding has increased by 11% compared to last year.
- Revenue for classroom supplies is 23% over last year.
- Interest continues to increase, now \$267,000 higher than last year through October.
- Overall revenue is now showing an increase of \$460,000 as of October.

EXPENSES

 Salaries and Benefits - Salaries are down by 3.75%, but benefits are now 8% higher than last YTD.
 All Other Items

 Equipment expenses are now up 40%, partially due to a \$30,000 indoor video display and \$28,000 for two riding scrubbers.

- Supplies have come down a bit but are still showing an increase of 47%.
- Expenses for Purchased Services have increased since September but are still 20% down compared to last year. ESC charges are currently \$336,000 lower than last year.
