General Information about Ordering Tickets:

All ticket order forms and payments must be received no later than Friday, June 10, 2011. We will make every attempt to seat you in the same manner as last year. If you wish to purchase more tickets than you had last year we will make every attempt to locate your new seats with the ones you had last year. If you have any special requests, please print instructions on the reverse side of your order form. If you have PSL seats you must still order tickets for each PSL you have purchased. **Please make sure to clearly print your complete name, address, and phone number on your order form.**

Relocation of Student Seating:

Please note that we plan to move the student seating so that we can better supervise the students and improve student school spirit by placing the students closer to the band area. Beginning with the 2011 football season students will be relocated to **Section H and Section J**. This will now open seats in Section A, and additional seats are available in Sections B, C, and G. If you are being displaced or wish to move due to the relocation of student seats we will attempt to "mirror" your seats in the available sections if you so desire.

Terms & Conditions of PSL Ownership

You are entitled to occupy your seat at any Ross home football game, including Ross home playoff games, as long as you purchase and maintain Ross season football tickets. If you fail to renew your Ross season football tickets, you forfeit your seat license right.

You are also entitled to purchase a ticket and maintain your seating right to all special ticketed events at the stadium for which you purchase a ticket. This **does not include**: graduation ceremonies, state playoff games or any St. Joseph Central Catholic football games and events.

The cost per license is \$600. This is payable with a \$200 deposit at application, then the balance of the commitment is payable on the anniversary of your application over the following two (2) years. Failure to pay full license fee within three (3) years shall cause forfeiture of the seat license. All disagreements shall be determined by the Board of the Fremont Area Athletic Foundation and their determination shall be final and binding.

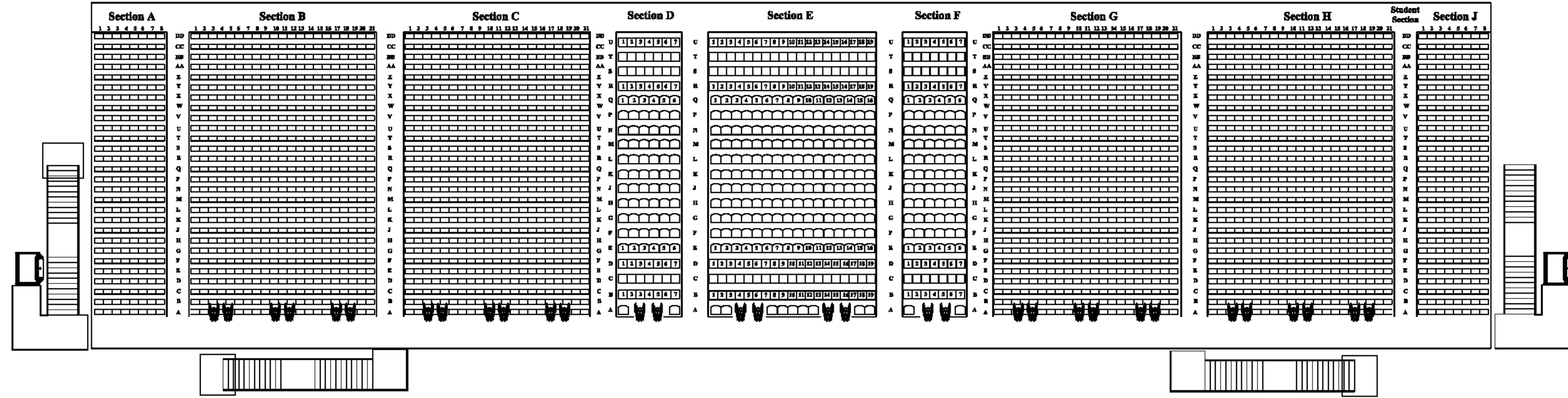
This seat license is only transferable to immediate family members upon the death of the seat licensee. Fremont Area Athletic Foundation reserves the right to cancel the seat license or any licensee if they engage in objectionable conduct while exercising their rights as a licensee.

I have read and understand the terms and conditions for ownership of a Fremont Ross Private Seating License. I approve the inscription to be put on my PSL name tag.

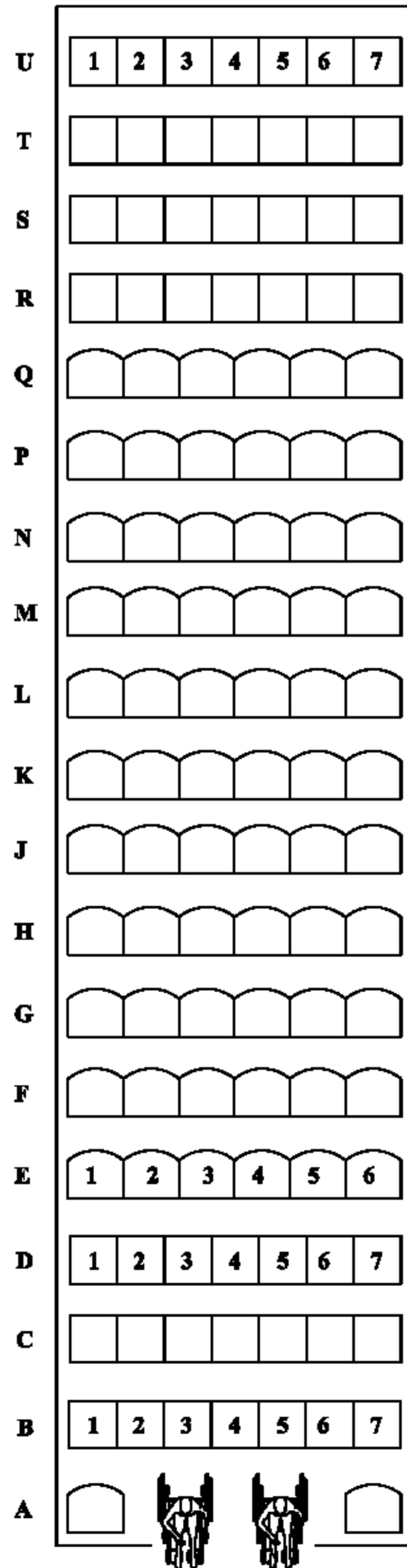
