#### **Resolution for Executive Session (O.R.C. 121.22)**

WHEREAS, as a public board of education, the Fremont City School District Board of Education may hold an executive session only after a majority of a quorum (or, in the case of item O, below, a unanimous quorum) of this board determines by a roll call vote to hold such a session and only at a regular or special meeting for the sole purpose of the consideration of any of the following matters:

- C. To consider the dismissal of a public employee or official.
- D. To consider the discipline of a public employee or official.
- E. To consider the promotion of a public employee or official.
- F. To consider the demotion of a public employee or official.
- G. To consider the compensation of a public employee or official.
- H. To consider the investigation of charges or complaints against a public employee, official, licensee, or student.
- I. To consider the purchase of property for public purposes.
- J. To consider the sale of property at competitive bidding.
- K. To confer with an attorney for the Board concerning disputes involving the Board that are the subject of pending or imminent court action.
- L. To prepare for, conduct, and/or review negotiations or bargaining sessions with public employees concerning their compensation or other terms and conditions of their employment.
- M. To consider matters required to be kept confidential by federal law or regulations or state statutes.
- N. To discuss details relative to the security arrangements and emergency response protocols for the Board.
- O. To discuss confidential information related to an application for economic development assistance, or negotiations with other political subdivisions related to the application, as executive session is necessary to protect interests of the applicant or related expenditure of public funds. (Unanimous vote required.)

#### **RECOGNITION OF VISITORS**

Dr. McCaudy welcomed everyone and made a few announcements.

Dr. McCaudy announced that Ross High School held their production of Footloose last weekend with almost sold out crowds for each performance. There were 746 tickets sold for the three performances. The cast and crew did an outstanding job, as did the Fremont City Schools' staff that was involved. She congratulated all the students who performed and worked on the production. She expressed a special thank you to Director Dennis Pita, Technical Assistant Scott Havice, Business Managers Alyssa Nye and Ashley Wharton, Costume Director Rebecca Pita and Chorographer Katie Hubley for all of their hard work. Dr. McCaudy announced that the event, Hidden in Plain Sight, was held yesterday at the Fremont Middle School. On stage, was a bedroom of a teenager that was recreated and the audience members were shown where drug paraphernalia might be hidden, as well as common household items that could be indicators of drug abuse. Sheriff Hilton and Chief Bliss presented and both of them shed light on the need for parents to start talking early and often to their children to help eliminate those types of risky behaviors from happening.
