Recommendations of the Superintendent

Mr. Detwiler presented his plan and explained his recommendation of a temporary mask mandate.

He introduced 2 guests:

- Dr. Iracema Aravelo She is a Pediatric Physician and came to share her experiences as a provider in this community. She provided a Power Point handout.
- Dr. Mary Bower, She presented some data to answer questions presented at the last Board Meeting.

Mr. Detwiler read a letter from Sandusky County Public Health Commissioner, Bethany Brown.

Mr. Detwiler proposed a three week temporary mask mandate that would start on Monday, September 27, 2021 and go through October 15, 2021. A reevaluation will be made as it gets closer to that end date.

This would be an indoor mandate. We will continue with masks for indoor extra curriculars and events.

Masks can be taken off for outdoor activities where three feet of separation can be maintained.

Phys Ed teachers are permitted to remove masks for physical activity if 6 feet of distance is possible.

Quarantine rules would still apply within three feet.

This mandate would be for all persons regardless of their vaccination status.

A doctor's note will be required for exemptions.

Bus masking will continue unless the federal rules change.

The refusal to wear a mask will be handled as a low level insubordination with escalating consequences.
