

## An Update From Fremont City Schools Superintendent Mr. Jon Detwiler

Greetings Fremont City School Families,

On March 24, 1997, the Supreme Court of Ohio declared the public school funding system unconstitutional. For 21 years, legislators have failed to address the issue. The funding system that we have in Ohio has become so complicated that it is very difficult to understand. The current system forces many districts to repeatedly go to their communities for additional funds. This process erodes the public's confidence in our school leaders.

Fremont City Schools has done an admirable job managing its budget and has not received additional operating money since 2003. The levy on the ballot on Tuesday, May 8<sup>th</sup>, is not additional money. It is a Renewal. This levy was originally passed in 1993 and has been passed in its current form every five years since 2003. This will be the fourth renewal of this levy. The citizens of Fremont have seen this as a necessary funding source since the students in our current senior class were three years old.

If the Renewal Levy does not pass, we would have to eliminate over 150 employees to make up this loss of revenue. Please vote on May 8th.



#### FACTS ABOUT THE RENEWAL INCOME TAX (1.25%) LEVY

On May 8, 2018, Fremont City Schools will ask the Fremont community to vote on the RENEWAL Income Tax Levy.

- Passage of the RENEWAL Income Tax Levy will NOT increase taxes.
- ✓ This 1.25% income tax generates \$7.75 million per year and makes up 19% of the District's total revenue.
- ✓ These monies are used to pay day-to-day operating expenses of Fremont City Schools.
- ✓ This **RENEWAL** is necessary to maintain the District's current services and programs for our students.

#### FREQUENTLY ASKED QUESTIONS

1. Will this RENEWAL Income Tax Levy increase my taxes?

No. This is a RENEWAL levy. No increase.

2. Who pays the RENEWAL Income Tax?

All Fremont City School District residents pay the 1.25% income tax through employer withholdings, individual quarterly estimated payments or annual returns.

#### 3. Why is the levy on the ballot now and what is the length/duration of the RENEWAL Income Tax?

This 1.25% income tax was RENEWED in November 2012 for five years and will expire in December 2018. In order to maintain the current services and programs for our students for another five years, the support of the community is needed.

#### **HISTORY COMES TO LIFE FOR ATKINSON FOURTH GRADERS**

The Sandusky County Park District has brought two great educational programs to our classrooms this year. The first was in the fall to discuss how this area was formerly *The Great Black Swamp*. Recently, Deb Nofzinger visited our 4th grade classrooms to talk to us about the Algonquin Native American tribes that once inhabited our area. Their round shelters with round roofs, which were called wigwams, were constructed from long, tall, skinny trees. Holes were dug in a circle and the poles were placed in the holes. They would use mats woven from cattails in the summer months and bark peeled off of trees in the winter months to cover the poles.

After the presentation, the students were invited to participate in several hands-on activities that Deb had brought along with her. Students had the opportunity to grind corn, add water to pipe stone to create a paint-like substance that they could put on their skin, and carry a cradle board that the women would have used to carry their small children around with them on their backs while they worked. Many animal hides were also brought so that the students could see what it would have been like to have to scrape the meat off in order to properly clean the hide. It was a fun-filled and exciting morning! Thank you to the Sandusky County Park District for sharing your resources and knowledge with us!







#### **MINERS FOR A DAY**

Washington Elementary School students were recently treated to a combination of fun and education when Matrix Mining Company paid a visit and students became miners for a day!

Each student received a two pound bag of Gemstone Mining Rough that included over 3 oz. of

gemstones, a collection bag, a scoop of Gold Mining Rough (pyrite a.k.a. fool's gold), a small plastic container, and an illustrated ID card to identify the gems. The ID card had pictures on the front for visual comparison as well as a few facts about each gemstone on the back, including which were birthstones.

Mr. Matt Hoffman, owner of the Matrix Mining Company, shared a few fun facts with the students about the California Gold Rush and the origins of many gemstones, specifically which ones were

mined in the United States. Gems mined in the U.S. include jasper, obsidian and many different types of quartz.

The students got a feel for how hard miners had to work for each little flake of gold they found all while waiting on the BIG payday!

### **A CERAMIC ROSE FOR MOM**

Second grade students at Stamm Elementary School got their hands dirty to make something quite beautiful for their mothers just in time for their honorary day! Students were first taught how clay is created naturally by the geological weathering of the earth's surface.

They learned that clay is used to make forms and sculpture that have height, width, and depth, also known as 3-dimensional art.

Students were shown by Mrs. Pollick, their art teacher, how to roll and model 8 spheres from large to small and then flatten them into pancakes. Overlapping these discs slightly from biggest to smallest, students rolled them up gently pinching and modeling them as they went to create the rose. They were then shown how to model two leaves to place as a base underneath their blossom. They will later glaze them to add a brilliant hue!

Students also discussed the symbolic meaning of a rose and words such as love, beautiful, delicate and special were mentioned....sounds like the perfect description of a Mom, too!

#### **ENTREPRENEURSHIP PROJECT**

Mr. Adame and Mr. Gallagher's Little Giant Pathway students recently completed a unit on entrepreneurship. In the unit, students created their own small businesses and presented them to their class Shark Tank style. Each class voted for what they thought was the best idea and a prize was given to the selected student. 

# **DIGITAL EMPOWERMENT PROJECT**

On March 22, 2018, all students at Fremont Middle School had the opportunity to hear from Scott Frank. In 2012, Scott formed Safely Intact LLC. Scott spent 12 years as an "Internet Crimes Against Children (ICAC)" investigator. His role as an investigator was to pose as a child. The world that he found himself immersed in was almost beyond descriptive words. In 2005, he began presenting the DIGITAL DIVIDE program to parents, educators and children. Since that time, he has provided vital information on the risks of the digital world to thousands of presentation attendees.

When he spoke with students at FMS, he shared with them the impact that the digital world has on all of us. On his website, Scott stated, "I knew that my investigations were important and they were making a difference – one online predator at a time. But my heart told me that I had to do more, that I needed to share my unique perspective on the risks and dangers of the digital world. I knew that I needed to empower others to make safe and healthy choices in their digital lives."

A parent event was also held on March 27, 2018. At that event, information was shared with parents regarding the digital world and the dangers that exist for students. Both events were very informative and beneficial for all who attended.
