- 1. The September 5th minutes were reviewed. A motion to accept the minutes was made by Art; seconded by Cindy. Motion carried.
- 2. The Treasurer's Report was presented. A motion to accept the report was made by Joe; seconded by Nancicarol. Motion carried.

- 4. Old Business
 - Staff Visitations Cindy shared that visits are complete
 and went very well. There were a few grant related
 questions and they addressed those to the best of their

 with more explanation on criteria used to award
 grants. Joe will look at grants awarded during the past

5. New Business

• Grant Program Donation – The Class of 1963 would like to donate to the teacher grant program; they have collected approximately \$14,000 with hopes of funding initiatives for 10-15 years. A motion to accept the Class of 1963 donation was made by Joe; seconded by Art. Motion carried. Bob and Joe will meet and discuss the possibility of expanding on this as a fundraiser. Thank you letters will be sent from the foundation to the individual donors.

• Grant Proposals

Grade 1 – Stamm - Discussion was held on finding or creating perpetual funding for grant requests such as this book club request since this is the second year of this request. Are there other sources or does the foundation place a limit on the number of years it funds a project. A motion to approve the grant in the amount of \$300 was made by Art; seconded by Shantel. Motion carried.
