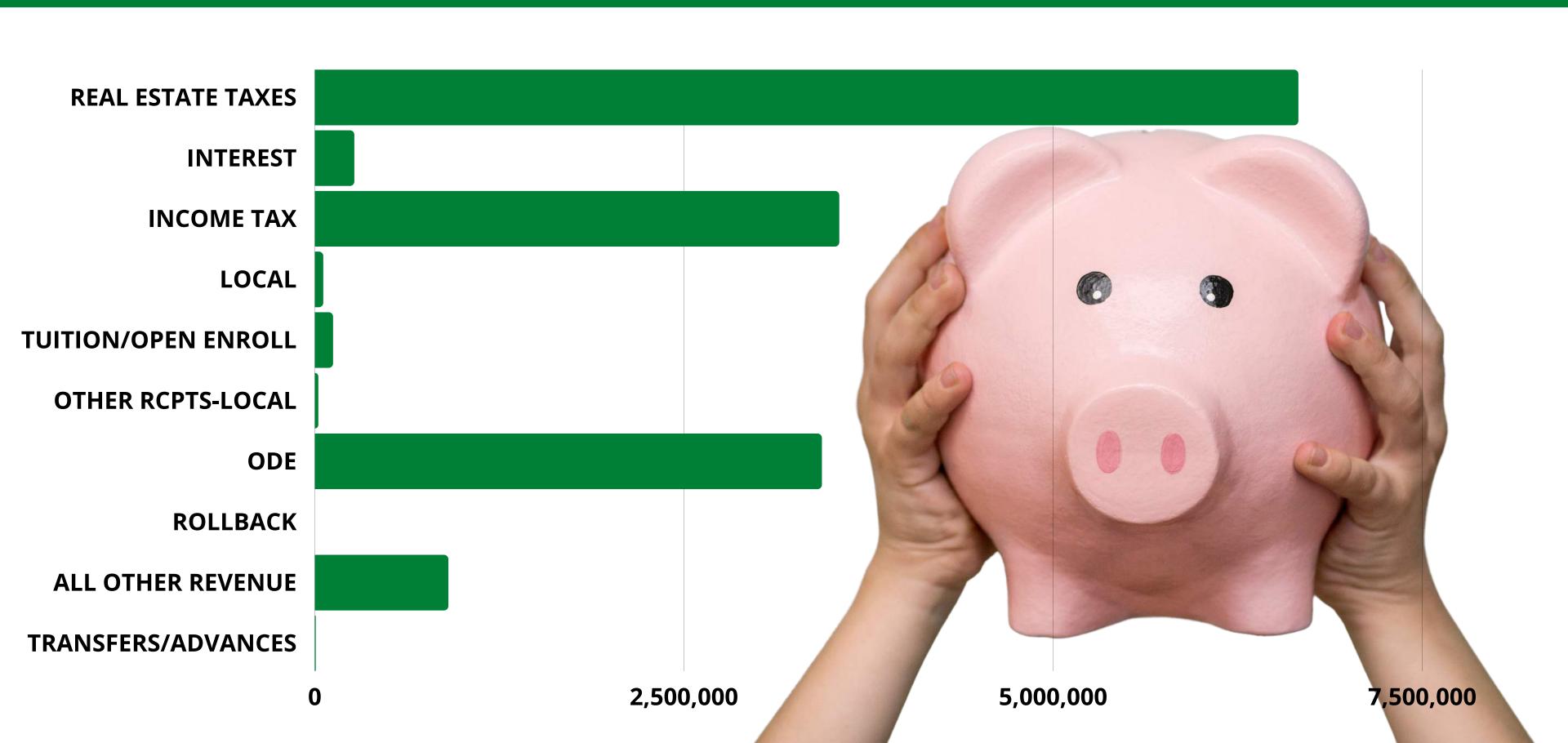

REVENUE



REVENUES

- No revenue yet this year for Rollback and Homestead, although we'd received \$730,000 last September.
- Income tax is still down about 5%.
- Tuition & Open Enrollment came in at \$121,514 through September, whereas last year we'd received just \$6,688.
- Student fees for classroom supplies are 40% higher than last YTD.
- Interest has increased by \$210,000 compared to last year at this time.
- Overall revenue is down by \$720,000 compared to last YTD.

EXPENSES

 Salaries and Benefits - Salaries are down by 3.6%, and benefits are still up by 4%, but lower than the 9% last month.

All Other Items

- Equipment expenses are down 58%, but supplies are still showing an 84% increase from last YTD.
- Legal services are up by \$47,000, due in part to a \$31,000 payment to Sandusky County Sheriff's Dept. for SRO officers.
- Phone service charges are down 59% through September, or \$14,000.
- Fuel charges are \$19,000 higher than last YTD.
